GENERAL INFORMATION

- The covered exhibition area in the Fair Centre is divided into conventional indivisible modules of 16 m² (4 by 4 meters).
- Areas greater than 16 m² must have a total area consisting of multiples of 16 m² (32; 49; 64; 80; 96; 112 ecc.)
- Areas are assigned until the whole exhibition space has been used up.
- Assignment of exhibition places is completely at the discretion of the Organizer (see Art.7 of the General Conditions for Participation).
- The fee, expressed per square metre, covers hire costs for exhibition space, and all costs for the services expressly listed in the General Conditions of Participation in the Exhibition and in the Exhibition Technical Regulations, and also covers any complementary events arranged by the Organiser, such as the conventions, conferences, celebratory and social events listed in the exhibition's programme, and the reception of delegations of professional operatives and any Italian or foreign state dignitaries, speakers and conference participants.
